Minutes of November 16, 1994 Annual Meeting

- SUBJ: <u>Report of the President</u> September 29, 1994 - October 26, 1994

This month, the College converted the administration of its health benefit program from an indemnity plan to a third party administrator. Under this plan, the College will be selfinsured, with individual and aggregate stop-loss insurance for claims. While the coverage provided under this new arrangement is transparent and will not affect employee benefits, the College stands to achieve significant savings, which will permit us to contain our escalating health care costs without changing the level of coverage currently offered to our employees. The change was communicated to the entire staff and workshops were held to answer questions.

This month, preparation began on the FY'96 budget. As a member of the Finance Committee of the Council of County Colleges and of the Budget Committee of the newly formed Council of Presidents, I assisted in the preparation of the FY'96 budget request, which was presented to the New Jersey Commission on Higher Education. A copy of the Council of County Colleges Request is attached to this report.

In Academic Affairs, our Engineering Technology Programs were visited by Accreditation Board of Engineering Technologies. Based on the exit interview on October 21, 1994, it is my impression that the visit went well. We will receive a preliminary accreditation report within 6-8 weeks.

In addition to chairing weekly meetings of the Executive Council and teaching my class, other activities this month included attending meetings of the MCC 2000 Task Forces on Faculty/Staff Development and Affirmative Action; a meeting with the Marketing Art & Design Department; a meeting of the Finance Committee of our Board; and giving an interview to <u>The New York Times</u>.

In addition, I was pleased to join Dr. Carlos Hernandez, President of Jersey City State College, in a panel discussion on "Models for Success for Hispanic Students" and to congratulate the 1994 Presidential Scholars. Off-campus, I attended a meeting of the New Jersey President's Council Budget Committee and a meeting of the Council of County Colleges Finance Committee and the Committee on Collective Bargaining.

A bit further off-campus, I attended a meeting of the Iona Board of Trustees and a meeting of the Board of TIAA/CREF.

On October 3, the MCC Foundation held its Twelfth Annual Fall Golf Classic at the Metuchen Country Club. The event was very well attended and netted over \$18,300 for the endowment fund.

Finally on Saturday evening, October 22, 1994, I was pleased to attend the Twenty-Fifth Anniversary Celebration of Hostos Community College. A reception was held in my honor.

# COMMUNITY COLLEGE FISCAL YEAR 1996 STATE BUDGET REQUEST

New Jersey's community colleges are the largest (see Attachment 1) and by far the fastest growing colleges (see Attachment 2) in the state. Nearly 140,000 New Jerseyans enrolled at one of the 19 community colleges in the Fall 1993 semester, the highest enrollment ever recorded. This represents a 32 percent increase in enrollments at community colleges since 1987.

Most people are surprised if not shocked when they are told that about half of the undergraduate students now in college in New Jersey are at a community college. That's right! Of all the undergraduates in college in New Jersey, about half are community college students.

Clearly, the people of the state are catching on to the powerful role community colleges can play in their own lives and for the future of the state in general. They are "voting with their feet" in record numbers each year as they enroll at their local community colleges. This is the good news.

Unfortunately, the bad news is that state policymakers in New Jersey have never provided adequate funding to community colleges. State law says that the state should pay at least 43 percent of the "educational and general costs of the county colleges." The state has never come close to fulfilling that obligation. In 1994-95, the state will provide about 20 percent of the funding for community colleges, with the counties and student tuition providing the other 80 percent.

Here are several compelling reasons why the state needs to substantially increase its investment in its 19 community colleges.

First, while community colleges remain absolutely committed to providing educational opportunity to those who need it, without adequate state funding it will become increasingly difficult to remain New Jersey's "opportunity colleges." Simply put, serving more students (see enrollment growth noted above) requires more funding.

Second, community colleges have a special obligation to keep tuition low since most community college students are from low- and middle-income families. New Jersey's community colleges are committed to keeping tuition low, but they cannot do it without adequate state funding.

Third, lack of state funding for community colleges means higher local property taxes. All New Jerseyans agree that property taxes are too high. Yet the lack of adequate state funding for community colleges has directly contributed to higher property taxes. For every dollar not provided by the state, another dollar in property taxes must be raised by the counties. And this is exactly what occurred over the past decade. This trend must be reversed. The state must provide its fair share of community college funding. SEP-21-84 WED 08:53

Fourth, a comparison of state funding of community colleges to funding for the public schools is especially noteworthy. Much attention has been given recently to the fact that some of the poorest "special needs" school districts spend only \$4000 to \$5000 per atudent. That is, on average, what community colleges are spending on <u>all</u> of their students.

Fifth, community colleges are one of the state's most important resources for job training and state economic development initiatives. Proof of this is seen in the new Workforce Development Partnership Program passed by the Legislature. This program provides grant monies to companies and to individuals directly so that they can participate in customized training programs. Last year, community colleges received over 80 percent of the training dollars awarded to higher education through this program.

# RECOMMENDATION ON FOUNDATIONAL AID FOR COMMUNITY COLLEGES

Community colleges have lost substantial ground through the annual state budget process for higher education over the past several years. For example, community colleges once received about half of what the four-year state colleges received in state funding per FTE, but now receive only about 20 percent of what the state colleges receive per FTE.

One of the main reasons for this is that historically the state has paid all or part of the negotiated salary increases for the four-year colleges and universities each year, while not doing so for community colleges. In other words, for the senior institutions, state funding has always been a two-step process - base funding plus salary money. In contrast, state funding for community colleges has always been simply a one-step process - base funding.

The impact of this practice is rather dramatic for the most recent state budget for FY 1995. The Governor recommended (and the Logislature approved) level base funding for community colleges and modest cuts in base funding for the rest of higher education. By this standard, it seemed that community colleges were treated very fairly.

However, the State Budget for FY 1995 also provides approximately \$80 million in salary money for the senior institutions. This results in a significant overall increase in state funding for the four-year institutions (about 11 percent) in comparison to overall level funding for community colleges.

It is easy to see how this state budget practice, repeated over the years, has resulted in a severely deteriorated funding position for community colleges in comparison to the rest of higher education. Like the rest of higher education, community colleges have negotiated salary increases. To remedy this situation for FY 1996 and beyond, the New Jersey Council of County Colleges proposes that foundational aid for community colleges in part be tied to negotiated salary increases at community colleges. More specifically, the Council of County Colleges proposes the following:

When the State fully funds the salary program for the fouryear colleges and universities, it should fund half of the community college salary program.

Note that this recommendation assumes that community college negotiated salary increases are less than or equal to those for the four-year colleges. If this is not the onso in a given year, the state participation in the community college salary program could be capped at half of the percentage increase in salaries at the four-year colleges.

What would this recommendation mean in FY 1996? New Jersey's 19 community colleges estimate that their salary increases for the coming year will total approximately \$21 million. Thus, for example, if the state budget for the four-year colleges in FY 1996 provides level base funding plus full funding of the salary accounts, then a comparable state budget recommendation for community colleges in FY 1996 would be level base funding plus \$10.5 million for the state's share of the community college salary program.

THIS MEANS A FY 1996 STATE BUDGET OF \$108.3 MILLION FOR COMMUNITY COLLEGE OPERATIONAL COSTS (\$97.8 MILLION IN FY 1995 PLUS \$10.5 MILLION FOR THE STATE'S SHARE OF COMMUNITY COLLEGE SALARY INCREASES). THIS WOULD SIMPLY KEEP COMMUNITY COLLEGES ON A PAR WITH A STATE BUDGET FOR THE FOUR-YEAR COLLEGES OF LEVEL BASE FUNDING PLUS FULL FUNDING OF THEIR SALARY PROGRAM.


Additionally, community colleges have certain fixed expenses (utilities, etc.) that will automatically increase due to inflationary pressures. Assuming an inflationary increase of 5 percent, New Jersey's 19 community colleges will require \$5 million in new revenues in FY 1996 simply to provide the same level of services as last year.

THIS BRINGS THE TOTAL FY 1996 STATE BUDGET REQUEST FOR COMMUNITY COLLEGE OPERATIONAL COSTS TO \$113.3 MILLION. THIS WOULD PROVIDE FOUNDATIONAL AID FOR NEGOTIATED SALARY INCREASES PLUS OTHER INFLATIONARY INCREASES.



First of all, on behalf of the entire College, it is my pleasure to welcome Mr. Geoffrey Vaccarelli as our 1994 graduating class representative to the Board of Trustees and to congratulate our new Board officers.

This month, a great deal of time and effort was invested in identifying long-term funding issues, as they relate to our statewide system of higher education in general and to the funding of the community colleges in particular. To that end, on October 29, I attended a meeting of the New Jersey Commission on Higher Education, followed by a meeting of the New Jersey Commission on Higher Education Task Force on Funding and Tuition Establishment. The charge of the Task Force is to examine the funding of higher education in New Jersey in terms of tuition, cost-containment, programmatic excellence, quality control and accountability.

In addition to chairing weekly meetings of the Executive Council and teaching my class, other activities this month included: meetings with the Hispanic Faculty and Staff Association; a meeting of the Iona College Presidential Search Committee; a meeting of the Co-Operative Education Advisory Committee; a meeting with key staff regarding allocation of MCC Foundation Scholarship funds; and an interview with Marta Vega, Executive Director of the Center for Afro-Caribbean Studies.

Off-campus, I attended a meeting of the New Jersey President's Association; a meeting with Jane Brady and Trustees Jerry Katcher and Mary Jean Guidette with representatives of the Vo-Tech School • regarding areas of cooperation. In addition, I was pleased to bring greetings on behalf of the College at the Latin Heritage Month Program Opening at the New Brunswick Public Library, which was co-sponsored by our New Brunswick Center.

A bit further off-campus, this month, I attended a meeting of the Board of Directors of TIAA/CRE,F as well as meetings of the Audit and Executive Committees. I also met with the Executive Committee and the Committee on Academics of Iona College. On November 4, I made a preliminary visit to Dutchess Community College, Poughkeepsie, New York in anticipation of the upcoming accreditation visit, scheduled for Spring 1995. Finally, on November 11, I was pleased to join Trustees Ciatto, Katcher and Wernik at an all-day Community College Trustees Conference on the impact of the Restructuring Act on Higher Education.
